A LETTER FROM MS. AGRA



It's been an interesting 2020 for all of us. The pandemic has changed our lives in ways we could never have imagined. In response to these changes, Shannon

McKenzie (Ms. AGRA 2020/21), has taken her platform online.

In March 2020, when the Phoenix Pride Festival was cancelled, Ms. AGRA joined forces with community members to produce the first virtual pride festival in history. Virtual Arizona Pride was held in April and featured online vendors, webinars, drag shows and musical performances. Shannon created a virtual flashmob dance class as a special event for the festival. The festival was attended by thousands of folks from all over the state as well as some from other states.

She continued working with Virtual Arizona Pride to co-produce their Juneteenth Celebration which featured a diverse cast of BIPOC

performers. Sponsored by NextGen Arizona, the show highlighted Mr. and Ms. AGRA in a public service announcement encouraging viewers to register to vote. The Charlie's Show Dancers performed numbers choreographed by Shannon for the opening and closing of the celebration, The event was hosted by Felicia Minor and co-hosted by Shannon McKenzie and Christopher Ray (Mr. AGRA 2020/21). It was well received and reached over 40,000 viewers.

In July, she participated in two fundraisers (hosted by Tucson Pride royalty Lucinda Holliday and Justin Deeper-Love) called "One CommUNITY, Many Voices". The first for the Navajo Nation Covid-19 Relief Fund raised over one thousand dollars and the second for EON Youth Lounge raised a little over five hundred dollars.

She helped raise funds in August for IGRA, performing in their auction and show hosted by Nikki Starr (Miss IGRA 2020/21), Mr. AGRA first runner-up Ryan Knop was also a performer and helped behind the

scenes. AGRA board members Mark Christensen and Mark Boyd did an amazing job with the technical aspects of the show. She donated a "Drinks and Dancing" gift basket filled with a gift card for Total Wine, a gift certificate for a free Zoom dance lesson, wine accessories and goodies. The event raised over seventeen hundred dollars.

Shannon will be continuing her virtual event tour in September with more exciting fundraisers. On the 5th you can catch her at the AGRA Beach Party Fundraiser. On the 12th she will be a featured performer in "Save The Screening Room", an event being produced to rescue an important venue in Tucson.
